WHEREAS, the Borough of Laurel Springs (the "Borough"), acting through the Borough Council (the "Council"), determined by Resolution adopted by the Council on March 26, 2018 that certain areas within the Borough (collectively the "Rehabilitation Area") that includes Block 37, Lot 15 on the official tax map of the Borough of Laurel Springs, County of Camden, State of New Jersey, more commonly referred to as 1124 Stone Road (the "Property") is an "area in need of rehabilitation" as defined in and pursuant to the Local Redevelopment and Housing Law, N.J.S.A. 40:12A-1 et seq. (the "Redevelopment Act"); and

WHEREAS, the Masakatsu, LLC (the "Entity") Entity was formed to own and rehabilitate the Property under the Redevelopment Act; and

WHEREAS, the Entity owns the Property; and

WHEREAS, the Entity intends to rehabilitate the Property for use as a martial arts academy; and WHEREAS, the Entity has submitted to the Mayor of the Borough (the "Mayor") an application (the "Application") for a tax exemption pursuant to N.J.S.A. 40A:20-1 et seq. and Borough Ordinance 241-1 et seq. for the Project; and

WHEREAS, the Mayor has, pursuant to N.J.S.A. 40A:20-1 et seq. and Borough Ordinance 241-1 et seq., submitted to the Council and recommended approval of the Application; and

WHEREAS, the Council desires to approve the Application.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Laurel Springs that:
