# **ENGINEER'S REPORT** – Engineer Jeff

### CAPITAL ITEMS

## 2020 Road Improvement Program

NJDOT approved the combination of both the FY2019 and FY2020 projects together into one (1) bid package / contract. We are currently making final revisions to the Site Plans and combining them into one set. The Plans / Specs are anticipated to be sent to NJDOT within approximately two (2) weeks. Once comment is received final revisions will be made and the project will be advertised for a January or February bid date, which will allow for the start of construction in early Spring 2021.

## 2. 2021 Road Improvement Program

In November, the Borough received correspondence from NJDOT awarding a FY2021 Municipal Aid Grant in the amount of \$174,930.00 for the reconstruction of Trenton Avenue and Virginia Avenue. Our office will provide a proposal for engineering design and construction inspection services in the near future for the purposes of budgeting costs for 2021.

### 3. 2021 Transportation Alternatives (TA) Set Aside Grant Application

In November, our office submitted an FY2021 TA Grant application for streetscape improvements along West Atlantic Avenue in front of the Cord Mansion and the adjoining area. The improvements will be designed to mirror those of the existing adjacent downtown streetscape improvements. We will apprise the Governing Body of any news we received with regard to the grant application as it is received.

### 4. Laurel Lake Dam

NJDEP requires that dams that fall within the classification of Laurel Lake Dam be inspected at a minimum of once every four (4) years. Our office completed the physical inspection of the dam and we have completed the accompanying report, which has been submitted to NJDEP Bureau of Dam Safety.

- DIRECTOR OF PUBLIC BUILDINGS & GROUNDS Councilman Cruz reported that the Cord Mansion elevator installation is still on schedule and that the insurance adjuster was out to look at the damage at the Recreation Center from vandalism.
