PRESENTATION - 915 Stone Road - B41-L15 - Redeveloper Designation

Michael Aimino the legal representative and his client the property owner met with the Borough regarding the Redevelopment process. Unfortunately, his client was unable to attend due to the Yom Kippur holiday and was not present. He offered an overview of 915 Stones Road, which is Block 41, Lot 15. His client has owned the property for a while. It is a former dentist's officer. It is all small rooms on the first floor and a large single family apartment dwelling on the second floor. The owner has been unable to find commercial clients to fit into the first floor in the small rooms, therefore, they are hoping to redevelop the property into three age-restricted, over-55 apartments through the redevelopment process. There was discussion of this use, potential profit and three units toward the COAH obligation. There was discussion of having to be named a Redeveloper by Borough Council. There was discussion of distribution of a site plan, consistent reviews of the outside where not a lot of work would be needed, as it meets the zoning code for parking. His client runs a company through property rentals and also a construction company. Property Management is already onsite for the project. Mr. Aimino discussed interior drawings, saying they would be distributing interior drawings, saying the property is well set up for construction of apartments. There was discussion of the redevelopment process.
