#### RESOLUTIONS

 #049-2021 - AUTHORIZING EXECUTION OF A SHARED SERVICES AGREEMENT BETWEEN THE BOROUGH OF LAUREL SPRINGS AND THE TOWNSHIP OF VOORHEES

WHEREAS, the Borough of Laurel Springs wishes to enter into a Shared Services Agreement ("Agreement") with the Township of Voorhees to share services and reduce costs by working together to provide Certified Recycling Professional services for the Borough of Laurel Springs; and

WHEREAS, by entering into the Agreement, Voorhees and Laurel Springs agree that the shared service will benefit each respective entity; and

WHEREAS, Laurel Springs shall pay Voorhees for the provision of Certified Recycling Professional services as defined in the Agreement, attached hereto, and made a part hereof; and

WHEREAS, the parties hereto are permitted in accordance with N.J.S.A. 40:8A-1 et seq., the Interlocal Services Act ("Act"), to enter into an Agreement to provide jointly, or through each respective agency itself, such services authorized by the Act, including areas of general government administration;

- #051-2021 AUTHORIZING APPLICATION FOR THE SFY21 BODY-WORN CAMERA (BWC) GRANT PROGRAM

WHEREAS, the State of New Jersey, Department of Law & Public Safety, Office of the Attorney General (OAG) received funds from the SFY21 Budget to administer the Body-Worn Camera Grant Program; and WHEREAS, under the BWC Grant Program, law enforcement agencies are eligible to receive grant funding for the purchase of body-worn cameras and related expenses relative to Law Enforcement agencies requirement to store data from body-worn cameras using a tamper-proof digital evidence management system that is compliant with Criminal Justice Information Services and their ability to securely share data, while maintaining an audit trail and chain of custody; and

WHERAS, the funding is for a 60-month period from January 1, 2021 through December 31, 2025 and all funding is to be used towards the cost of implementing the Body-Worn Camera Grant Program and it is the responsibility of the recipient to maintain proof of all expenditures;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Laurel Springs authorizes the Laurel Springs Police Department to participate in the BWC Grant Program and to complete and submit an application package. WHEREAS, a contract in the amount of \$51,200.00 was awarded to Rodier Ebersberger Architects on March 13, 2017 by Resolution 042-2017, for the Design of the Stair Tower; and

WHEREAS, an amendment to the original contract was approved via Resolution 074-2019 – Change Order #1 to increase in the contract administration phase coast resulting in a net increase in the amount of \$12,120.00 and an adjusted contract in the amount of \$63,320.00; and

WHEREAS, another contract addendum has been submitted and is necessary in the form of Change Order #2 due to additional construction administration phase costs, resulting in a net increase in the amount of \$29,700.00 and an adjusted contract in the amount of \$93,020.00;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council that Change Order #2, which amends the original Stair Tower Design and Construction Administration contract with Rodier Ebersberger Architects for Removal of Architectural Barriers at the Cord Mansion, is hereby approved.
