NOW, THEREFORE, BE IT RESOLVED that the Borough of Laurel Springs hereby recommends to the New Jersey Department of Transportation that the contract for:

**RECONSTRUCTION OF WEST ATLANTIC AVENUE**

in the Borough of Laurel Springs, County of Camden be awarded to American Asphalt Company, 100 Main Street, West Collingswood Heights, NJ 08059, whose base bid Plus Alternate Bid 1 amounted to \$478,044.00 subject to the approval of the Department. That the presiding officer of this body be and is hereby directed to sign for and on its behalf the contract in the prescribed form for said construction. That the clerk of this body be and is hereby directed to seal said contract with the corporate seal of this body and to attest to same.
