NEW BUSINESS/CORRESPONDENCE

- Annual Tax Collector's Report The report was distributed to Council and reviewed by Mayor Barbera.
- Traffic and Parking issues Councilman Redstreake commented that he had hoped to speak with Chief Mazziotta and Borough Administrator Cheeseman before the meeting but had not. He had been made aware of a couple of parking and traffic issues. The first was Fairmount and Central where a request for a four way stop sign had been made. There is a slow down at Arch Avenue, but it picks up between there and Stone. There was conversation about the procedure for placing four way stops via action of the Governing Body. The second is Park Avenue and Stone, where a rental property has tenants parking past the sign that clearly says no parking. The Caterers' employees' vehicles also contribute to the issue. There is often a blue truck parked illegally. Something that is to be done there. The third instance is the vehicles from Clean Streak out in front of the stores on West Atlantic not allowing patrons to easily access the shops. He asked for a crack down on these items. There was conversation about he number of units in the apartment house on Park. Mayor Barbera said he would speak to the Chief.
- Ordinance Review Meeting Mayor Barbera said there were conflicts with the upcoming date, and he would be communicating with the members.

COMMENTS FROM THE PUBLIC

Bob Lickfield – 542 Glen Avenue – participated in the discussion about stop signs by saying he observed people blow through stop sign and described a near miss. He referred to information on the State website and more of his observations of four-way stops and parking too close to the intersection.

Cliff Jones – Saint Paul's Presbyterian – wanted to thank Council and the Borough for the Proclamation for appreciation. He wanted to give a word of explanation about the Dickens Christmas Festival and St. Paul's participation. The video presentation was not able to be shown because the vendor did not arrive on site, so he was disappointed by the way that happened and wanted to explain. Mayor Barbera said he had read Reverend Cliff's note of appreciation.
