- #082-2020 OPPOSING THE PROPOSED REALLOCATION OF THE STATE RECYCLING FUND

WHEREAS the State Recycling Fund provides an estimated \$24 million to municipalities and counties to fund mandated and essential recycling services to their constituents; and

WHEREAS, the market crisis which resulted in tipping fees for single stream recycling in the in the range of \$75 - \$100 per ton and higher and are in some cases exceed the cost of disposal causing severe budget constraints to cover unanticipated costs to maintain the mandated recycling services to their residents; and

WHEREAS the impact of COVID 19 with business and government shutdowns substantially increased residential recycling generation due to work from home policies and orders;

NOW THEREFORE, BE IT RESOLVED, by the Governing Body of the Borough of Laurel Springs, County of Camden that they urge the Senate Budget and Appropriations Committee and Assembly Budget Committee to keep the State Recycling Fund whole.

### **OLD BUSINESS**

**Police Contract Committee** – Mayor Barbera announced that he, Councilman Riondino and Borough Administrator Cheeseman would form the Committee to consider the upcoming Police Contract.

## **NEW BUSINESS/CORRESPONDENCE**

- From CFO Ciminera regard Bond Anticipation Notes, Series 2020A Mayor Barbera read the letter and said that the note was placed at a good rate with Amboy Bank.
- From NJDCA regarding the Best Practices 2020 it was confirmed that the material has been received and the process of completing the survey has been opened with the CFO.
- Reallocation of State Recycling Fund and Clean Communities Grant the Clean Communities potential reallocation was already resolved. The previous approved resolution concerned this reallocation, and the resolution will be sent to the Senate and Assembly Budget Committees.
- Halloween, Saturday, October 31st Borough Administrator Ken Cheeseman described Halloween traditions in the past on both weekends and weekdays. He said the Fire Department would not be holding the Halloween Parade due to COVID-19 concerns, and lack of fund-raising activities during the pandemic year saying the Halloween Parade costs the Volunteer Fire Department between \$600 and \$700. As a matter of tradition, trick or treat follows the parade on the weekends and school during weekdays. The Borough can set the time of curfew, but the choice to participate in trick or treat is up to individual families and individual homes. Unless the Governor sets something by executive order all towns are going ahead. There was conversation about letting people decide. There was conversation of home indicating participation by having their lights on or with decorations or holiday appeal. There

She also asked if there was an ordinance regarding trash cans being put away after pick up and when they are supposed to be brough in. Borough Administrator Cheeseman said by the evening of pick up. She said her neighbors are leaving them out for extended periods of time. She was asked to contact the Borough when this occurs and told that a letter would be sent out the following day with a copy of the ordinance.
