

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF LAUREL SPRINGS, COUNTY OF CAMDEN, STATE OF NEW JERSEY, AS FOLLOWS:

SECTION 1. Chapter 19, Section 1, of the Code of the Borough of Laurel Springs is hereby deleted and replaced with the following:

§19-1 Department Organization.

A Fire Department of the Borough of Laurel Springs shall consist of a Fire Chief, Assistant Fire Chief, Deputy Fire Chief, and those officers appointed by the Fire Chief, who shall accept the provisions and conditions of this article, and whose names shall be filed in the office of the Borough Clerk; provided, however, that none shall become a member of said Fire Department except by Resolution of the Borough Council.

SECTION 2. Chapter 19, Section 2, Officers, of the Code of the Borough of Laurel Springs is hereby amended by deletion of the second sentence which read as follows:

At the same time, a list of the names of appointed Fire Captains and Lieutenants who were appointed by the Fire Chief shall be submitted for appointment and confirmation by the Mayor and Borough Council.

SECTION 3. Chapter 19, Section 8 of the Code of the Borough of Laurel Springs is hereby deleted and replaced with the following:

§19-8 Eligibility; permission to join.

No person shall be eligible for membership in the Junior Firemen's auxiliary who is less than 14 or more than 18 years of age. Applicants for membership shall be required to obtain permission to join the Auxiliary from their parents or guardian. Such permission shall be in writing and notarized.

SECTION 4. Chapter 19, Section 11, Training Requirements, of the Code of the Borough of Laurel Springs is hereby deleted and replaced with the following:

§19-11 Training requirements.

The rules and regulations for the training of the Auxiliary shall be as set forth in the laws and regulations promulgated by the State of New Jersey.

SECTION 5. Chapter 19, Section 12, Education and training, restrictions on activities, is hereby deleted in its entirety.

SECTION 6. All ordinances or parts of ordinances which are inconsistent with the provisions of this Ordinance are, to the extent of such inconsistencies, hereby repealed.


SECTION 7. This Ordinance shall take effect upon final passage, adoption and publication in the manner prescribed by law.
